Timings for Planning Purposes:

The total period of time allowed for a burial straight to grave will be 30 minutes.

The total period of time allowed for a burial preceded by a 30 minute Chapel service will be 1 hour.

The total period of time allowed for the interment of cremated remains will be 20 minutes. Where these timings are expected to be exceeded this should be notified to the Cemeteries Office well in advance so that additional time can be set aside. Failure to do so may result in a penalty charge being made to offset extra costs.
