\*Additional fees are applicable to points 1/2/3 for those not paying Council Tax to Oxford City Council. Where proof can be produced that the deceased was an Oxford resident, prior to entering a care home in the preceding 5 years, the additional fee charge will be waived. This can be double-checked on our IT systems. Further fees will also be applicable for burials outside normal working hours to cover additional costs.

**\*\* Reclaimed graves have been previously buried in but the burial rights to the grave were not purchased therefore they remained under Council Ownership. In purchasing a Reclaimed grave you would purchase the burial rights and the interment cost. Coffin burials only cannot purchased to inter ashes.**

**Timings for Planning Purposes:**

The total period of time allowed for a burial straight to grave will be 30 minutes.

The total period of time allowed for a burial preceded by a 30 minute Chapel service will be 1 hour.

The total period of time allowed for the interment of cremated remains will be 20 minutes.

Where these timings are expected to be exceeded this should be notified to the Cemeteries Office well in advance so that additional time can be set aside. Failure to do so may result in a penalty charge being made to offset extra costs.
